## Electronic Submittal of APAs and Other Case Documents December 2, 2014

Effective January 1, 2015, documents submitted by the parties for individual Commissioner Hearings and Appellate Panel Hearings must be submitted to the Commission electronically by uploading each document as a separate file using the "eCase" portal on the Commission's website. Forms submitted via secure email, standard email or USPS will not be accepted as service on the Commission.

Prehearing Briefs and notice of witnesses must be uploaded before the hearing. The parties are required to bring copies of the APA submissions, exhibits, and depositions to the hearing for the Commissioner to review and keep any copies that he/she may deem necessary. After the hearing, each document type (APA submissions, exhibits and depositions) should be uploaded as separate documents to the Commission within 48 hours of the hearing. The upload process should not be considered as a substitute for service of any document on the other party/parties.

Attached is a table with the document type, document description, the requirement schedule for each submission and document format. Each type of document should be uploaded as a separate file. For example, the APA is one document and should be uploaded as one file. Each deposition should be uploaded as a separate file with the name of the deposed and the date of the deposition. Parties are directed to follow the instructions below to electronically submit documents to the Commission using the "eCase" portal on the Commission's website <u>www.wcc.sc.gov</u>. The size of the document and the speed of the party's Internet provider will be factors in the amount of time it takes to upload the document.

\*\*\*Please be patient and allow for the upload to be completed. Once the upload is complete, you will receive a popup box allowing you to review the document that was just uploaded. The document will not be submitted until you click the "confirm" button.

## Instructions to Electronically Submit Case File Documents

- 1. Go to the Commission's website <u>www.wcc.sc.gov.</u>
- 2. Click on the "eCase Login" tab at the top of the page.
- 3. Login to eCase.
- 4. Enter Search Criteria for the WCC case in question.
- 5. Results will display if link to case exists.
- 6. Click WCC# Hyperlink to display expanded Status History to show entire history of SCWCC's case file and reveal the Upload button.
- 7. Click the Upload File button and follow the on-screen instructions. Click the User Guide and Document Type Help buttons for more detailed instructions if needed.
