This report summarizes the activities of Human Resources during the month of May 2020.

In March the Commission had 51 FTE positions available. We have 1 part-time employee.

I met with management several times on a couple of employee-related issues and we have begun addressing the issues.

We sent 18 "All Agency" emails during the month.

In SCEIS, I had 8 SCEIS transactions. Payroll and time reports were run as scheduled. We processed no travel in the month of May.

We had 1 CBRE building issues and no parking issues.

Since March 23rd, I have been reporting to the State HR department data regarding who was working onsite, telecommuting, and taking leave. This is done daily.

Many hours have been spent on preparing for re-entry into the office. Policies were established, memos were sent to all employees regarding the return to work and more are ready to be sent at the appropriate time. PPE was purchased, tote bags with PPE and other items for the Commissioners' use were distribute and signage was installed.

Our EEOC report was completed and submitted as request.

I continued to track employees work activities from home. Once a week, I receive lists of the daily activities of those working from home. I take that data, summarize daily activities into a weekly summary by employee and add it to a spreadsheet for management's review.

For the month of May, we had an average of 13 employees working onsite, 36 employees working from home and average of 2 employees taking leave.

This report summarizes the activities and accomplishments of departmental projects and initiatives for the IT department during May 2020.

I. Systems Operations, Maintenance and Support

<u>EDI</u>

We are continuing to convert all EDI trading partner accounts to a new server with enhanced security. The team worked with multiple EDI Trading Partners identify specific reasons for data rejections on Claims and POC submissions. We continue our participation in IAIABC conference calls for Jurisdictions Only and for EDI Claims Committee and were asked to serve on the IAIABC's POC 3.0 XML Taskforce.

Progress

Progress EDI Claims and Coverage load programs were modified to function with the new EDI server with security upgrades. Duane resolved multiple errors with Payment/Invoice entries and Bank Deposit records. Liz Generated 140 X-files for this month and continued her work to map the new DEW data into our current interface.

Systems Support

During May, Jason's efforts were focused on supporting staff and building efficiencies in our work from home processes. We expanded our use of Zoom and CourtCall to aid in the continuity of business operations.

Reporting

We generated several Open Claims reports for external stakeholders and provided Compliance reports for internal staff. Additionally, we began work on the annual asset audit and inventory process as part of the IT Data Collection and Planning report to the Department of Administration.

<u>OnBase</u>

In our testing for the upcoming OnBase version, several issues were identified. Kim is working with DTO to ensure these obstacles are resolved and client upgrade process is as efficient as possible with minimal impact to our users.

Hardware

Our standard 3-year laptop refresh lifecycle has begun, and we are evaluating laptops from all state contract vendors.

II. Projects, Enhancements and Development

Legacy Modernization

We continue our working engagement with Microsoft as part of the gap analysis of our KERMIT project.

IMS welcomes any guidance that you and/or our Commissioners can provide concerning our performance and direction.

IMS COMPLIANCE DIVISION

Employer Rule to Show Cause Hearings and Compliance Activity

The Compliance Division docketed **0** new RTSC cases and **3** total RTSC cases in the month of April. And, compelled **10** South Carolina employers to come into compliance with the Act. Year to date, **58** new RTSC cases and **169** total RTSC cases have been docketed.

Employers Obtaining Coverage

Year to date, the Compliance Division has compelled **453** South Carolina employers to come into compliance with the Act. In so doing, approximately **3,478** previously uninsured workers are now properly covered.

Penalties Waived

Although the Division has assessed \$6.1 m in fines this fiscal year, \$5.8 m have been <u>waived</u> or <u>rescinded</u> as employers have either obtained insurance coverage or were found not to be subject to the Act.



Carrier Rule to Show Cause Hearings

The Compliance Division manages the Rule to Show Cause process involving the recovery of outstanding carrier fines and penalties . In the month of May 2020, 0 carrier RTSC cases were docketed; 0 cases for a total of \$0.

Year to date, a total of 138 carrier RTSC cases have been docketed, 136 cases for a total of \$61,946 have been resolved.





IMS COMPLIANCE DIVISION



The DEW Data Pool is determined by the total number of potential, non-compliant employers who report wages to DEW with at least 4 employees and who's FEIN does not match with any coverage records in the Commission's coverage database. The investigations generated is the number of compliance investigations generated from the pool. The investigations initiated is the number of compliance investigations initiated from those that were generated.



IMS COMPLIANCE DIVISION

Carryover Caseload:

The Compliance Division closed May 2020 with 225 cases active, compared to an active caseload of 510 at the close of May 2019.

Cases Resolved:

For the month of May 2020, Compliance Division staff closed-out 145 cases.

Compliance Fines:

In May 2020, the Compliance Division collected \$33,481 in fines and penalties. Year to Date, the Compliance Division has collected \$1,004,753 in fines and penalties.

IMS COVERAGE DIVISION

WCC Claim Files:

In May 2020, the Coverage Division received a total of 1,476 WCC Claim files. Of these, 1,264 were created through proper carrier filing of a 12A, and 212 were generated as a result of a Form 50 claim filing. Year to Date 23,155 Claim files have been created which is 95% of claim file volume prior year (24,289).

Coverage Fines:

The Coverage Division collected \$18,600 in fine revenue in May 2020, as compared to \$22,000 in Coverage fines/penalties accrued during May 2019. Year on Year, Coverage fines are at 47% of collections for prior year.





IMS SELF INSURANCE DIVISION

During the month of May 2020, the Self Insurance Division:

- * collected \$73,761 in self-insurance tax.
- * added 7 new self-insurers.
- * conducted 4 Self Insurance audits.

Year to Date, Self Insurance tax revenue is trending at 93% of prior year and 44 Self Insurance audits have been completed.





IMS MEDICAL SERVICES DIVISION

In May 2020, the Medical Services Division began the month with 9 bills pending review, received an additional 6 bills for review, conducted 7 bill reviews and ended the month with 8 bills pending.

RE: Monthly Judicial Report for May 2020

During the month of May, the Judicial Department processed six hundred seventy-six (676) requests for hearings, one hundred nineteen (119) Motions and one hundred twenty-nine (129) clincher conference requests that were sent to the Jurisdictional Commissioners.

There were fourteen (14) Single Commissioner Hearings conducted during the past month, forty-six (46) pre-hearing conferences held and two (2) Full Commission hearings held. A total of three hundred sixty-nine (369) Orders were served at the single Commissioner level, thirty-one (31) of those were Decision and Orders that resulted from hearings that went on the record and ninety-two (92) were Motion Orders that were a result of Motions ruled upon by Commissioners.

The Informal Conference system conducted one hundred eighty (180) hearings during the last month.

There were twenty-four (24) regulatory mediations scheduled and forty-one (41) requested mediations. The Judicial Department was notified of thirty-four (34) matters resolved in mediation, with the receipt of Forms 70.

In the month of May, Judicial received two (2) Notice of Intent to Appeal to the Court of Appeals and zero (0) to the Circuit Court.

Preparation of Return to Work

Staff continued to refine the work re-entry policies and procedures and procure personal protective equipment (PPE) in preparation for implementation of Phase 2 and staff re-entry in to the workplace in mid-June. Staff also prepared for the Commissioner's in-person hearings in Hearing A and Hearing B with the posting of signage and coordinating with CBRE.

Meetings/Activities

From May 13, 2020 to June 2, 2020 the Executive Director spent the majority of the time working from home. During this time he participated in 13 Zoom conference calls and webinars.

Constituent / Public Information Services

For the period May 13, 2020 to June 2, 2020, the Executive Director's Office and the General Counsel's office had 282 electronic and personal contacts with claimants or constituents, state agencies, federal agencies, attorneys, service providers, business partners; and letters with congressional offices.

Financial Transactions Activity

For the period May 13, 2020 to June 2, 2020 the Director's office processed and approved 4 travel expense reports, 96 invoices, and 68 deposits for DOA to process in the SCIES system.

For the period May 13, 20202 through June 2, 2020 we added three (3) individuals. Due to the receipt of email delivery failures, a total of three (3) email addresses were deleted. A total of 789 individuals currently receive notifications from the Commission.

Attached is the Budget vs. Actual Report for the General Fund and Earmarked Fund for the fiscal year period ending May 31, 2020. The benchmark for this period is 92%.

Expenditures

The expenditures for the General Fund are on pages 1-3. The year-to-day expenditures in the General Fund (10010000) for this period is \$2.4 million or 52% of budget.

The Earmarked Fund financials may be found on pages 4-10 of the "Budget vs. Actual Report FY2020. The year-to-date expenditures for the Earmarked Fund (38440000) are \$4.1 million or 73% of budget. The fund has \$265,000 of Commitments.

Revenues

The Earmarked Fund received \$2.6 million in Operating Revenues through May 31, 2020. This is 82% of budget. As noted last month the Training Conference Registration Fee (438002000) received is 23% more than the budgeted amount as a result of the six regional training sessions conducted last fall on KERMIT. The amount received in the Sale of Listing and Labels (448006000) account is substantially over the budgeted amount, which is most likely a coding error when the funds were deposited. We will make the appropriate transfer before the end of the fiscal year.

To date we have received \$4.5 million Self-Insurance Tax funds.
